

# President's Report

The seminar portion of the meeting will focus on the theory and practice necessary for the design and installation of Solar Energy systems utilizing Solar Thermal Technology. Rising fuel costs, stricter emission standards as well as government and utility incentives are many of the reasons for the recent push towards renewable energy sources like solar energy. This presentation will discuss the basics of solar thermal systems, including components, system design, financial feasibility and case studies. The goal of this presentation is to enlighten the engineering community to become more familiar with solar thermal systems and promote better system design.

Our speaker will be Mr. Ross Trethewey. Ross is currently an HVAC Solar Engineer at RST Thermal. Prior to working at RST, Ross worked as a Solar Engineer for a European heating and solar equipment manufacturer. It was there that he took part in a six-month internship at the company's research and development facilities department in Germany, Austria and France. 

# Legislative Report

# **Gas Pipe Sizing** ( Again???)

Again I will extend my congratulations to Paul Taylor, Nancy Bonetti and the rest of the product show committee for their outstanding effort in putting together a great Product Show in November. I had the pleasure of assisting in the seminars as a monitor. The seminars were terrific. I had the pleasure of hosting in one of the seminars members of the Mass Plumbing Board including the chair, Mr. Paul Kennedy, the Executive Director, Mr. Joe Peluso, and the Deputy Director, Mr. Wayne Thomas. These fine gentlemen gave of their time to come and discuss with us, some of the recent Board actions which impact all of us.

The Board's website is current and you can download the topics discussed from the site. The main topics discussed included Gas Piping, Gas piping tables, Secondary Roof Drainage, and clarification of total allowable length of domestic water piping serving heating fan coils.

A point of discussion was the fact that the Board has reached out to ASPE Boston Chapter in the past during their deliberation of policy and code changes. It has been my pleasure over the past five years or so to participate in this dialogue. I have found the Board to be very respectful and deliberative of our ASPE Boston input. That brings me to the point of this article.

If you refer to my March 2011 article (on the ASPE Boston website) regarding Gas piping, we discuss the Board's acceptance of NFPA 54 gas piping methodology. Reading further, however, you will see that the Board still requires in low pressure systems (those below 14" w.c.) a system total loss of 0.5 "w.c. This was discussed around the seminar room.

NFPA 54 allows the pressure drop in the system to be engineered so that the only stipulation is that there is enough pressure at the end of the system to run the equipment. I was asked by a couple of engineers to pursue this.

The Plumbing Board will listen to any proposal put forth by ASPE and I believe that a request to have the Board except the NFPA 54 method is reasonable. We need to however to submit documentation to them that is scientific and supported by documentation.

If you are interested in pursuing this request of the board, please e-mail me with your thoughts and supporting documents. The way I have handled this in the past is to put together a draft which I run by an informal group of our interested members, assemble and incorporate their comments and then submit to the Board.

#### ASPE - Society Reports:

The following was authored by Gretchen Pienta and is re-printed for information purposes.

#### ASPE and IAPMO Agree to Develop Green Plumbing Design Certification.

The International Association of Plumbing and Mechanical Officials (IAPMO) and the American Society of Plumbing Engineers (ASPE) have entered into a Memorandum of Understanding (MOU) to train, test, and certify qualified plumbing engineers and designers in the United States to perform green plumbing design work, to design systems that conserve and protect water supplies and reduce energy consumption in the delivery and use of water.

The organizations recognize unique characteristics in each association that make this agreement a viable and worthwhile endeavor. According to the MoU:

- IAPMO will develop a green plumbing design curriculum based in part or whole upon current green plumbing and green plumbing inspector curriculum, with input and possible additional curriculum provided by ASPE.
- The Green Plumbing Design program will be tied to the current ASPE Certified in Plumbing Design (CPD) program by requiring the CPD as one of the eligibility requirements for sitting for the Green Plumbing Design exam.
- IAPMO and ASPE agree to co-promote the Green Plumbing Design program, as well as the Green Plumbing Inspector and Green Plumbers Training programs.

IAPMO and ASPE, through the use of the IAPMOLearn staff and industry subject matter experts, will coordinate the overall course development, hours of instruction, method of delivery, and cost of instruction and assessment of the Green Plumbing Design program. "ASPE is proud to have IAPMO as one of our key strategic partners, and this new endeavor in the area of green plumbing design training and certification is just one example of how our two organizations can work together to serve the plumbing community," said Jim Kendzel, MPH, CAE, ASPE Executive Director/CEO. "The availability of plumbing professionals having validated knowledge in green design based on sound engineering practices will be a major force in advancing green building design concepts in the future."




