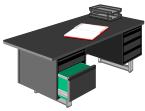

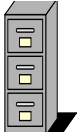

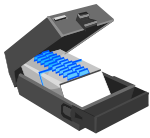

Membership News

This month instead of posting a reminder to those Chapter members who need to renew their membership, I am offering some information that you should all be aware of. I decided to report about **Carbon Monoxide poisoning** after a family member had a CO emergency in her home. The CO level was up to 70 ppm before she ever heard the detector going off. I admit I didn't know how dangerous that level was until I found this information on the US Consumer Product Safety Commission website. Please read this information and see to it that your home is properly protected with both smoke detectors AND Carbon Monoxide detectors. And change the batteries if you haven't already!

What is carbon monoxide (CO)?

Carbon monoxide (CO) is a deadly, colorless, odorless, poisonous gas. It is produced by the incomplete burning of various fuels, including coal, wood, charcoal, oil, kerosene, propane, and natural gas. Products and equipment powered by internal combustion engines such as portable generators, cars, lawn mowers, and power washers also produce CO.

How many people are unintentionally poisoned by CO?

On average, about 170 people in the United States die every year from CO produced by non-automotive consumer products. These products include malfunctioning fuel-burning appliances such as furnaces, ranges, water heaters and room heaters; engine-powered equipment such as portable generators; fireplaces; and charcoal that is burned in homes and other enclosed areas. In 2005 alone, CPSC staff is aware of at least 94 generator-related CO poisoning deaths. Forty-seven of these deaths were known to have occurred during power outages due to severe weather, including Hurricane Katrina. Still others die from CO produced by non-consumer products, such as cars left running in attached garages. The Centers for Disease Control and Prevention estimates that several thousand people go to hospital emergency rooms every year to be treated for CO poisoning.

What CO level is dangerous to my health?

The health effects of CO depend on the CO concentration and length of exposure, as well as each individual's health condition. CO concentration is measured in parts per million (ppm). Most people will not experience any symptoms from prolonged exposure to CO levels of approximately 1 to 70 ppm but some heart patients might experience an increase in chest pain. As CO levels increase and remain above 70 ppm, symptoms become more noticeable and can include headache, fatigue and nausea. At sustained CO concentrations above 150 to 200 ppm, disorientation, unconsciousness, and death are possible.

CO Alarms

CPSC recommends consumers

- Replace the batteries in their smoke and CO alarms annually;
- Test the alarms monthly.
- Smoke alarms should be on every level of the home, outside sleeping areas and inside each bedroom.
- CO alarms should be installed on each level of the home and outside sleeping areas.
- CO alarms should not be installed in attics or basements unless they include a sleeping area.
- Combination smoke and CO alarms are available to consumers.

Safety Tips

- Have your home heating systems (including chimneys and vents) inspected and serviced annually by a trained service technician.
- Never use portable generators inside homes or garages, even if doors and windows are open. Use generators outside only, far away from the home.
- Never bring a charcoal grill into the house for heating or cooking. Do not barbeque in the garage.
- Never use a gas range or oven for heating.
- Open the fireplace damper before lighting a fire and keep it open until the ashes are cool. An open damper may help prevent build-up of poisonous gases inside the home.
- Install battery-operated CO alarms or CO alarms with battery backup in your home outside separate sleeping areas.

Know the symptoms of carbon monoxide poisoning:

Headache, dizziness, weakness, nausea, vomiting, sleepiness, and confusion. If you suspect CO poisoning, get outside to fresh air immediately, and then call 911.

Because CO is odorless, colorless, and otherwise undetectable to the human senses, people may not know that they are being exposed. The initial symptoms of low to moderate CO poisoning are similar to the flu (but without the fever). They include: Headache, Fatigue, Shortness of breath, Nausea and Dizziness.

High level CO poisoning results in progressively more severe symptoms, including: Mental confusion, Vomiting, Loss of muscular coordination, Loss of consciousness, Ultimately death.

Symptom severity is related to both the CO level and the duration of exposure. For slowly developing residential CO problems, occupants and/or physicians can mistake mild to moderate CO poisoning symptoms for the flu, which sometimes results in tragic deaths. For rapidly developing, high level CO exposures (e.g., associated with use of generators in residential spaces), victims can rapidly become mentally confused, and can lose muscle control without having first experienced milder symptoms; they will likely die if not rescued.

Legislative Report


It was great seeing you all and reconnecting at last month's meeting after the longer summer break.

At September meeting fellow member approached me and asked about the Plumbing Boards interpretation of plumbers work, the installation of flue gases and when the interpretation was enacted. The official interpretation can be found posted on the board website at the following location: <http://www.mass.gov/ocabr/licensee/dpl-boards/pl/board-policies/education-policies/regarding-licensure-necessary-to-engage.html>. The policy was enacted October 25, 2006. In summary, the interpretation states that all venting of flue gases for large equipment above 400,000 BTU/hr may be installed by a qualified individual but the license master plumber or gas fitter is responsible for and shall supervise work as installed by said individual. All equipment less than 400,000 BTU/hr shall be installed by a license master plumber or gas fitter. For private work, referencing the HVAC drawings for the scope of the flu work should be adequate. For public work, it has been my experience that the scope of the flu or any other work to be installed or overseen by a license plumber or gas fitter should be included in the plumbing construction documents.

Other Legislative News: On September 3, 2014, the plumbing board voted to accept the new Massachusetts State Fuel Gas Codes. The official date of enactment is still to be determined by the plumbing board. The board voted to accept all proposed amendments, a draft of the amendments can be found posted on the board website at the following location:

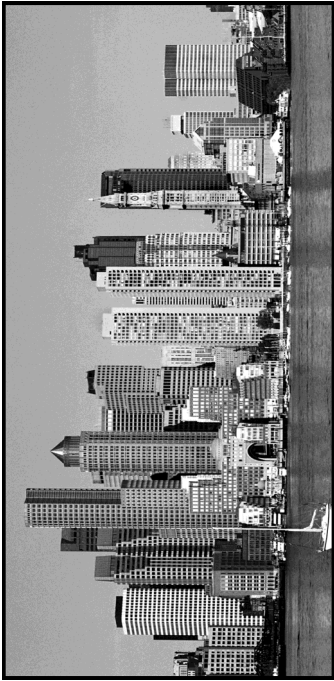

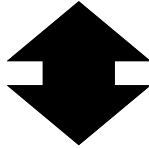
