

Technical Report










Legislative Report

When dealing with pipe routing that may get installed close to electrical

equipment and/or electrical control panel, the electrical code restricts the space above the electrical equipment as dedicated electrical space to allow conduits to enter and leave the equipment. It also restricts the space in front of the equipment to allow access to the equipment (working space). However, the electrical code does not restrict the space above the working space. Therefore, the space in front of the equipment is working space, which is not a dedicated electrical space. Based on the attached diagram from the 2014 NEC, locating the Pipe in the space above the working space is allowed.

The following image can be found in the 2014 NEC. Although this is not part of the code language, it makes the intent of the code pretty clear.


